I agree:

1. To install and maintain at my expense, the necessary service line to cause the property described above, which is owned or occupied by me, to be connected with the waterworks system at the property line.
2. To Pay:
 - a. All charges connected with any required water hookup including but not limited to excavation, pipe boring, etc. where a new meter installation is being done.
 - b. A water availability charge, when necessary, to run a spur or additional line to new property lines involved. This includes all costs incurred by the authority and in addition, shall include a ten percent (10%) fee for all paperwork necessary. If it becomes necessary to cross a road, either blacktop or gravel, then this will be a separate charge, in addition, to those mentioned above.
 - c. A meter deposit, being refundable, in accordance with the rules and regulations of the authority, in accordance with the present deposit fees.
3. Not less than the minimum water bill after notification by the authority that service is available. To pay promptly for the water at the applicable rate schedule. Net bills payable by the 15th, 10% penalty after the 15th, and disconnect after the 25th of the month.
4. To abide by and comply with all the rules and regulations and by-laws of the authority, a copy of which I have received. I understand that failure to do so may result in the termination of my agreement.
5. I certify this water service connection is for the sole use of my property or rental and that there are no extensions of pipes to transfer water to another property. I, also, certify that the water will not be resold, or sub-metered: except in an emergency or specific situation which shall be done only on specific written permission by the authority for the duration of the emergency.
6. It is further understood that if, for any reason, the authority is unable to provide me with water service anticipated by this application, the full amount of this application would be refunded to me.
7. On a new meter installation, it is required that the minimum water bills be paid for a period of three (3) years even if the service is not being used by the owner.

This membership is issued and accepted in accordance with and subject to the conditions and restrictions stipulated in the Articles of Lakeview Midway Public Water Authority's By-Laws and Amendments.
