I agree to the following:

1. To install & maintain at my expense, the necessary service line to cause the property described above, which is owned or occupied by me, to be connected with the waterworks system at the property line.
2. On a NEW METER INSTALLATION, if for any reason, the LMPWA is unable to provide water service anticipated by this application, the full amount of this application would be refunded to me. Once installed, it is required that the minimum water bill be paid for a period no less than 3 (three) years, even if the service is not being used by the owner.
3. To pay: **A)** All charges connected with any required water hookup including but not limited to excavation, pipe boring, etc., where a new meter installation is being done. **B)** A water availability charge, when necessary, to run a spur or additional line to new property lines involved. This includes all costs incurred by the authority and in addition, shall include a 10% fee for all paperwork necessary. If it becomes necessary to cross a road, either blacktop or gravel, then this will be a separate charge, in addition to, those mentioned above. **C)** A meter deposit, being refundable, in accordance with the rules and regulations of the authority, in accordance with the present deposit fees.
4. Pay promptly for the water at current rate schedule. **Net bills payable by the 15th.** A 10% penalty is added after the 15th. **Water service will be disconnected if not paid by the 25th; all past due and disconnect fees must be paid before reconnection.**
5. Abide by and comply with all the rules and regulations and by-laws of the authority, a copy of which I have received. I understand that failure to do so may result in the termination of my agreement.
6. I certify that this water service connection is for the sole use of my property or rental and that there are no extensions of pipes to transfer water to another property. I also certify that the water will not be resold, or sub-metered except in an emergency or specific situation which shall be done only on specific written permission by the authority for the duration of such emergency or situation.
